



Executive Summary

The deliverable complements *D1.3 – Doctoral Thesis* and *D2.1 – Doctoral Theses* (M54). As per the Grant Agreement (GA) awards may be given after the end of the project, as ESRs may require more than 3 years to finalise their degree and submit their thesis. Additionally, academic or administrative requirements may delay the awarding of degrees.

1. Introduction

The aim of this deliverable is to provide information on the University of Alicante (UA) Early Stage Researchers (ESRs) and the status of the degrees awarded at the end of the visuAAL project (2025). The deliverable complements *D1.3 – Doctoral Thesis* and *D2.1 – Doctoral Theses* (M54 – February 2025), which contains copies of ESR15's thesis and thesis drafts (ESR13, ESR14). As per the Grant Agreement (GA) awards may be given after the end of the project, as ESRs may require more than 3 years to submit their theses and finalise their degrees. Additionally, academic or administrative requirements may delay the award of degrees.

In total, three ESRs were recruited by UA and a summary of their status at the end of the project is as follows:

- **ESR13** Plans to submit his thesis before Summer 2025 for defence in September 2025.
- ESR14 Plans to submit his thesis before Summer 2025 for defence in September 2025.
- ESR15 Submitted her PhD thesis in July 2024 and defended it and obtained her PhD degree on 13 September 2024.
